ZwickNet Terms of Use

These Terms and Conditions are effective on March 14, 2024.

By using the ZwickNet website, the ZwickNet Service, or any applications (including mobile apps) made available by Kyan Zwick (all together, the "Service"), accessed through any means, you agree to being bound by the following ("Terms and Conditions"). The Service is owned, and controlled by Kyan Zwick, which is not a registered company. These Terms and Conditions affect your legal rights and obligations. If you do not agree to any of the following Terms and Conditions, please do not access or use the Service.
